THIS AGREEMENT MUST BE SIGNED BY THE PERSON IN CHARGE

This form is required for each motor vehicle participating in the **2025 78th Annual Bremerton Armed Forces Day Parade**. The owner and operator of the vehicle is required to complete this form and provide a copy of the registration and insurance for the vehicle. Failure to provide the required information, or submitting false or misleading information, will immediately disqualify the vehicle, owner, and operator from participation in the **2025 78th Annual Bremerton Armed Forces Day Parade**.

In consideration of the acceptance of this application, I agree to release and hold harmless the **78th Annual Bremerton Armed Forces Day Parade, the Greater Kitsap Chamber, and the City of Bremerton**, and all their directors, officers, agents, representatives, employees, and volunteers and to promptly indemnify same from and against any and all claims, actions, damages, liability of every type, and nature, including all costs and legal expenses incurred by me or any other party, by reason of any activity arising under or in connection with my participation in the **78th Annual Bremerton ARMED FORCES DAY Parade**, including loss of life, personal injury, and/or damage to property arising from or out of any occurrence, omission or, activity relating to such participation.

In the event **78th Annual Bremerton ARMED FORCES DAY Parade** shall be made a party to any litigation commenced by or against me, I shall proceed and hold harmless the **78th Annual Bremerton ARMED FORCES DAY Parade, the GREATER KITSAP CHAMBER, the City of Bremerton** and shall pay all costs, expenses, and reasonable attorney's fees incurred or paid by them in connection with such litigation.
